Finding Aid for St. Louis County Medical Examiner Records and Coroner Reports, 1940-1990

First, find the person in the index cards (Rolls 03-01 through 03-07). To do this you will need the person's name and approximate date of death. Depending on the year, you may have to check more than one index:

- For Dec 1940-May 14, 1953, all coroner reports were indexed together
- For May 15, 1953-Dec 1980*, cases were separated into two categories: **natural** deaths and **violent** deaths

*Index cards for **natural** deaths from May 15, 1953-Dec 31, 1961 do not exist, but indexes are included in the finding aid located in the History & Genealogy Department and [online](#).

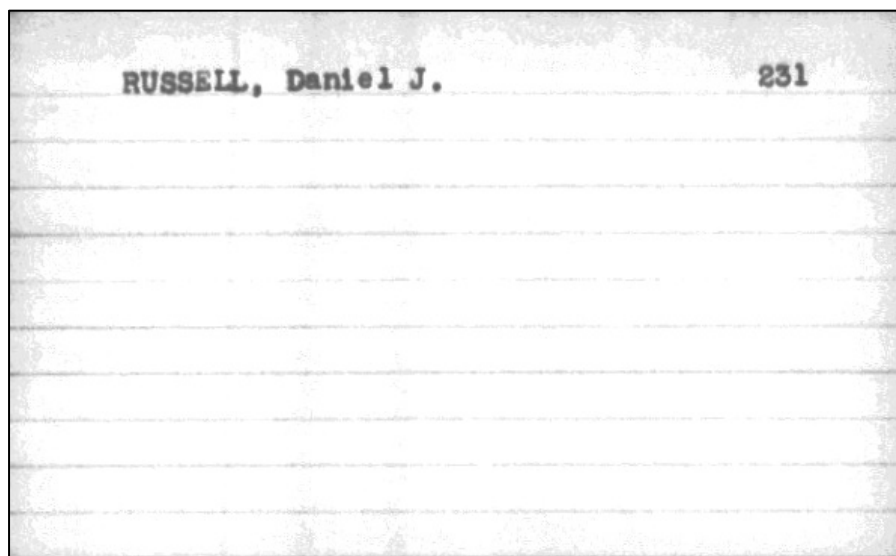
- Due to how the records were microfilmed, the compiled indexes also include 1962.

- For 1981-1990**, all deaths were indexed together

**While our *index cards* go up to 1990, we only have the *case files* through 1985. Nevertheless, even the index cards themselves have some useful information on them.

What's on an Index Card?

Content depends on the year. In the early 1940's, the index card will only include the name and case number. More information will be found in the case file.



Violent Deaths

From the late 1940's onward, index cards for violent deaths generally include the name of the deceased, their case number, race, gender, age, address, date of death, summary, and if an inquest was held, the date and the verdict; sometimes includes fee for removals (which may mention funeral homes, undertakers, mortuaries, etc.) Note the changes over the years in the pictures below.

Other Indexes

Some indexes cover more than just natural and violent deaths. There are some indexes for homicides, inquiries, and perpetrators, etc. In some cases, the index cards aren't sorted by the victim, but by the suspect involved.

For cases where the suspect is unknown, the cards are sorted by the victim.

Finding the Case Files

Now that we've seen some index card examples, let's figure out how to get from the index cards to the coroner's reports or case files. The three key pieces of information needed for this are the person's name, date of death, and the case number. Using that information (along with the spreadsheet located at the end of this guide) we should be able to find out which rolls of microfilm we need.

We'll start with our example of VIRGIL J DALLER.

He died in 1947 and his case number is #483. Using the spreadsheet to first locate the year, we can see that his case file will be on Roll 05-11.

The same process applies for GEORGE E BIGGS, even though his case number looks a little different.

His case number is #85-2929. The beginning two numbers simply indicate the year. Use the remaining four numbers along with the spreadsheet to determine that his case file will be on Roll 07-52 part 3.

Finding Natural Death Case Files

Both of the above were examples of violent deaths, so let's see how they compare to natural deaths. As is just so happens, coroner reports for natural deaths from 1945-1980 are sorted differently than violent deaths. They are sorted by the first letter of their last name and usually in reverse date order.

Let's look at the case of ROBERT LEE CALDWELL.

How do we find someone without a case number? Easy. Since we know he died in 1962, we just use the spreadsheet to locate natural deaths for that year. His last name begins with a C, so his case file will be on Roll 08-118 part 2.

Now take a look at LEE ANN JACUS, who died in 1979.

She has a case number of N1066, but remember that case files aren't important for natural deaths in this year range. Using the spreadsheet reveals her natural death case file will be on Roll 08-96 part 2.

So what about natural deaths that occur between 1981 and 1985? Take a look at MARY R ROSSO, who died in 1985.

As noted earlier, all cases were filed together from 1981 onward, so we will need to use her case file number (N85-0298) and the spreadsheet to determine that she is on Roll 07-43.

Helpful Hints

- If the person you're looking for died in a year when index cards were separated, be sure to check both sets. Sometimes natural death index cards are filed with violent deaths, and vice versa. Be sure to check adjacent years as well.
- Note that Mc's are often separated from the M's, both in the indexes and in the coroner's reports of natural deaths.
- Case numbers reset at various times for different reasons. Be sure you have the right date range on the spreadsheet to go along with the case number.

What's in a Case File?

The contents of a case file depend on several factors. Two of the more important ones are the **nature of death** and the **time period** in which it occurred.

These documents give us a fascinating look into the final moments of the lives of our ancestors. Not only can they provide us with vital record information about the decedent, they can also give us some context which may lead to further clues for family research.

Miscellaneous Files, 1977-1981

For these years, there are "miscellaneous" file folders which actually include documents from 1975-1982. These folders contain all sorts of various records. They may contain death certificates, radiology consultations, police reports, and other odd bits of information. These file folders were loosely put into date order, but due to their disorderly nature, two indexes for these records are included in this finding aid. The first index has names *sorted alphabetically*, and second has the names *listed in order of appearance*.
