Introduction
Rev. Joseph Hessoum, the third pastor of St. John Nepomuk Church, arrived in St. Louis on September 30, 1865. The church in America had been closed for over a year due to the lack of a Czech-speaking priest. Hessoum's arrival had been delayed because of the shipping blockade imposed during the Civil War. "He understood that a Bohemian Catholic publication was absolutely necessary to the faith of the people. The parish was still in relative disorder, the people were poor, some had dropped off from the faith. So it was necessary that the word of God reach them not only from the pulpit but also from the press."¹ Hessoum described the severity of the situation in a letter to his nephew in Bohemia.

We wish to find a Catholic Czech newspaper in these parts. It is absolutely indispensable here. If a large part of our people is not to perish in unbelief and degradation. The periodical Pástor published in this city, ceased publication—we purchased all the rights and intend to turn it into a Catholic newspaper. I just closed the sale today for \$2500.00 of which sum \$300.00 is to be the down payment, the balance to be



French, French Canadian, Acadian and Huguenot

American-Canadian Genealogist: Official Journal of the American-Canadian Genealogical Society. Manchester, N.H.: American-Canadian Genealogical Society, 1991–present. 973.0411 G3261.

A New Hampshire-based organization publishes this quarterly periodical which emphasizes Acadian, French-Canadian and Franco-American ancestry. Back issues are in processing at this printing.

French Canadian and Acadian Genealogical Review. Québec: Centre canadien des recherches généalogiques, 1968–1981. 971.4 F873.

Even though this quarterly review was only published for a few years, it is an excellent resource for French-Canadian and Acadian genealogical and historical research.

Articles published in this quarterly emphasize the French Colonial past in North America.

Were the Maccabees French, Scottish, Irish or Jewish?

This is the principle quarterly publication for French-Canadian genealogical research. It is in French, but researchers should easily recognize names and dates.

The Huguenot. [U.S.?]: The Huguenot Society of the Founders of Manakin in the Colony of Virginia, 1926–present. R 975.5355 H897H1.

Manakintown, Virginia was a large Huguenot (French Protestant) settlement in the 1700s. Descendants of these settlers are now scattered all over the U.S. *The Huguenot* is published biennially.

German

This quarterly publication includes information of both a genealogical and historical nature.

Der Kurier [The Courier]. Silver Spring, Md.: The Society, 1982–present. R 973.0431 K96.

Published quarterly by the Mid-Atlantic Germanic Society, *Der Kurier* covers Germans in the Mid-Atlantic area, but also includes articles of interest to German researchers throughout the U.S.

German Genealogical Digest. Pleasant Grove, Utah: Jensen Publications, 1985–2004. R 943 G373.

Considered by many to be the premier resource for German genealogical research, the quarterly *German Genealogical Digest* ceased publication in 2004. It remains widely used to this day.

Journal of the American Historical Society of Germans from Russia. Lincoln, Neb.: American Historical Society of Germans from Russia, 1978–present. R 973.0431 A512J.

Beginning in 1762, many Germans migrated to Russia during the reign of Catherine the Great. By the end

of the 19th century, there were about 1.8 million Germans living there. In 1872, they began to emigrate to the United States, Canada, Brazil, and Argentina. This quarterly journal covers their history in Russia and elsewhere.

Mennonite Family History. Elverson, Pa.: Mennonite Family History, 1982–present. R 289.7 M547.

An excellent resource for Mennonite, Amish and Brethren genealogy and family history, *Mennonite Family History* is published quarterly.

The *Swedish American Genealogist* is the go-to resource for Swedish American biography, genealogy and personal history.



Shelf life

BOOK | Early Settlers of Indiana's "Gore," 1803–1820




Before the opening of the Indiana Territory, a sliver of Indiana was part of Ohio. This southwestern section of Indiana is known as the Gore region, and it became home to some of the state's earliest Anglo-American settlers, who ventured across the Ohio River from the turn of the eighteenth century. The Indiana Gore region includes the current counties of Dearborn, Franklin, Ohio, Randolph, Switzerland, Union, and Wayne. In her book *Early Settlers of Indiana's "Gore," 1803 to 1820* (R 977.2 M363E), compiler Shirley Keller Mikesell brings together the records of historical Dearborn County, from which the other Gore counties were formed.

An 1826 courthouse fire in Lawrenceburg, the county seat of Dearborn, destroyed many of the genealogist's go-to records. To help mitigate this loss for researchers, Mikesell transcribed settlers' names from letters, petitions, and War of 1812 muster rolls in the first part of her book. While genealogical data from these sources can be sparse compared to birth, marriage, and death records, there is enough to ground an ancestor or family in place and time.

The majority of the book is comprised of abstracts of various land records from the Gore counties. These record types include, among others, tract books, deeds, mortgage deeds, quitclaims, and bonds up to 1820. Because the Gore was originally part of Ohio, its early land records survived in Cincinnati. Ohio County was formed later, so its deeds are included with the Dearborn records. An index is provided in the back of the book.

JOURNAL | The Casselman Chronicle



As Americans pushed west from the Mid-Atlantic States, many of them passed through the Casselman River Valley in western Maryland and Pennsylvania. Consequently, *The Casselman Chronicle* should be of interest to many researchers.

Typical issues include articles about people living in the area (much like a county history),

and information about the historic practices of the area, such as drying apples (Vol. XLVII, 2007 No. 1) or making sauerkraut (Vol. XLVII, 2007 No. 2). This type of article will usually include recipes so modern readers can experience making the foods of their ancestors. Other articles tell the history of a local congregation, such as Zion Lutheran Church in Jennings, Maryland (Vol. XLIX, 2009 No. 1).

Occasionally the publication will include indexed information such as the 2012 survey of Lower Springs Cemetery, Springs, Pennsylvania (Vol. LII, 2012 No. 1), or a list of Amish ministers and bishops originating from the Old Order Church of Somerset County, Pennsylvania from 1894 to November 2010 (Vol. L, 2010 No. 2).

History & Genealogy at St. Louis County Library has a complete run of this periodical. Additionally, indexes for all years are available in the collection. Researchers can find articles of interest by searching PERSI (Periodical Source Index). Browsing the pages is another option. A subscription to the quarterly is included with a membership in the Springs Historical Society of the Casselman Valley.



- Entries for variants direct the reader to the main entry where the history and etymology of the name is covered
- Contains a full list of published and unpublished sources consulted
- Introductory essay explains the origin, history, and typology of family names in Britain, Ireland, and elsewhere in the world, the research methods used, the sources used, and some of the problems encountered in researching family names



Profiles in Survival: The Experiences of American POWs in the Philippines During World War II

The stories of seven men and one woman from Indiana who survived the horrors of captivity under the Japanese in the Pacific during World War II are captured in vivid detail. These Hoosiers stationed in the Philippines were ordered to surrender following the fall of Bataan and Corregidor in 1942. It was the largest surrender of American armed forces in U.S. history. For many, it was the beginning of three years of hell, starting with the infamous Bataan Death March, facing brutal conditions in POW camps in the Philippines, and horrific journeys to Japan on what came to be known as “hellships.”—*Adapted from book jacket*



Children Bound to Labor

The history of early America cannot be told without considering unfree labor. At the center of this history are African and Native American adults forced into slavery; the children born to these unfree persons usually inherited their parents' status. Immigrant indentured servants, many of whom were young people, are widely recognized as part of early American society. Less familiar is the idea of free children being taken from the homes where they were born and put into bondage.

The authors of *Children Bound to Labor* show the various ways in which pauper apprentices were important to the economic, social, and political structure of early America, and how the practice shaped such key relations as master-servant, parent-child, and family-state in the young republic. In considering the practice in English, Dutch, and French communities in North America from the mid-seventeenth century to the mid-nineteenth century, *Children Bound to Labor* even suggests that this widespread practice was notable as a positive means of maintaining social stability and encouraging economic development.—*Publisher*

My Dear Molly: The Civil War Letters of Captain James Love

Upon the outbreak of the Civil War, James E. Love enlisted as a sergeant in the United States Reserve Corps, and left St. Louis with his fellow Union soldiers on June 15, 1861. The following day, James sent the first of many letters home to Eliza Mary "Molly" Wilson, the beloved fiancée he left behind. A prolific writer, James continued to write to her, 160 letters in all, for the duration of his Civil War service. These letters are now part of the archives at the Missouri History Museum in St. Louis, and the Museum published the letters as a book, *My Dear Molly: The Civil War Letters of Captain James Love*.
