What's really "special" about the Special Collections Department?

One of the goals of *PastPorts* is to introduce readers to sources held by the Special Collections Department and offer guidance and tips to their use. We diverge a bit in this issue by highlighting some of the Department's unique or rare collections—some of the things that make the department truly "special."

Unique and rare print collections

Based on searches in WorldCat <<http://worldcat.org>>, an online union catalog (database) listing the holdings of most U.S. libraries, the following items are either owned solely by St. Louis County Library or only a few other libraries in the U.S.

Regularly scheduled tours of the Special Collections Department are conducted on the first Wednesday and third Saturday of the month at 10:30 am. No advance registration is required. ■ **Noel Pion Collection**—Approximately 400 volumes of French-Canadian church record transcriptions, primarily marriages. Although individual titles are listed in WorldCat as being owned by multiple libraries, the Special Collections Department has an unusually large collection. The books originally belonged to genealogist Noel Pion, who died in 1981, and were donated to the library by his family in 2007.

■ **Family histories**—The Special Collections Department holds more than 12,000 family histories. Many of them are unique and unavailable at any other library, and many can be checked out or obtained through interlibrary loan services.

■ **French surname books**—A growing collection of 40 titles published in France. Each volume discusses family

names originating in a particular *département* (state). Articles offer information about a name's origins, meaning, spelling variations, historical significance and other information. Volumes are shelved beginning at R 944.11 N799. As with *Ortssippenbücher* (see below), French surname books are held by few other libraries in the U.S., commonly the Library of Congress, and a few large academic libraries or research collections, such as Harvard University and New York Public Library.

■ **Yizkor Book Collection**—Yizkor books, written by Holocaust survivors to memorialize Jewish villages destroyed during the Nazi regime, feature photos, maps, memoirs, testimonies, histories and lists of Jews who were killed. The Department began acquiring the books in 1999 after staff members consulted with St. Louis Jewish Genealogical Society members Art and Sylvia Jaffe about

potential acquisitions. The books were purchased from a bookstore in New York City that was found to have a significant number of volumes for sale. The Department's collection of 116 titles, written primarily in Yiddish and Hebrew, are rare publications held by only a few other libraries. ■ **Marxkors emigration books**—Dr. Heinz Marxkors, retired university professor in Bielefeld, Germany, has done extensive research in German and American church records as a result of queries he received as researcher for his local Catholic diocese. Christy Human Hughes, former Special Collections Department assistant manager, became acquainted with Marxkors in the late 1990s when she contacted him about her own genealogical research. A collegial relationship developed between the two. When Marxkors decided to self-publish his research, the Special Collections Department was quick to purchase his books.

The collection consists of two major sets. The first is comprised of 15-volumes with genealogical information about emigrants from various towns in the former Kingdoms of Hannover and Westphalia to the U.S. Titles begin *Auswanderer aus...* [Emigrants from...] and are shelved at R 943.56 M392A. The other set of nine-volumes focuses on emigrants to St. Libory, St. Clair County, Ill. Titles follow the format, *Emigrants from the Former County/ies of....In St. Libory, St. Clair County, State of Illinois / U.S.A.* and are located at R 977.389 M392E. The Department staff created a [name index](http://www.slcl.org/branches/hq/sc/indexes/marxkors/marxkors-main-index.htm) <<http://www.slcl.org/branches/hq/sc/indexes/marxkors/marxkors-main-index.htm>> to make the volumes assessable to researchers.

■ **Scottish Memorial Transcription Books**—The Special Collections Department acquired more than 400 volumes of Scottish tombstone and memorial tablet transcription books in 2009. The idea for the acquisition can be credited to StLGS member Mary Berthold, who located and ordered the books and made sure that payment was received by the publishers in Scotland. Mary also helped finance the purchase, along with StLGS members Joyce Mercer, Pat Stamm, Ilene Murray and Ted Steele. The collection is shelved beginning with call no. R 941.135 M533.

■ **Ortssippenbücher**—Translated literally as “local clan book,” an *Ortssippenbuch* contains extensive genealogical information about families in a particular village or parish

in Germany or other German-speaking area. Extracted from church and civil records, data can date back to as early as the 16th century and sometimes earlier. Information is usually presented in family groups with cross-referencing within the book and sometimes to other *Ortssippenbücher*. Some titles are owned only by St. Louis County Library. The Department has a growing collection of about 400 *Ortssippenbücher* and similar publications.

■ **Luthman Funeral Home Records**—As researchers know, sometimes it is one specific source that can make the difference between progress and stalemate. One such unique source in the collection are records for Luthman Funeral Home, Dayton, Ohio. The records, covering 1906 – 1982, were donated to the St. Louis Genealogical Society (StLGS) by Eloise Luthman and Society member Carol Bell in 2005 and subsequently added to the Department's collection. The records comprise 21 bound volumes and are shelved at R 977.172 L973. Information in the collection can be quite detailed and commonly give place of birth, including the exact town name for immigrants, and name of parents.

■ **Community newspapers**—Local community newspapers are often overlooked and hard-to-find sources for genealogical research. The Department has bound volumes of the *Claytonia Tribune*, 1973 – 1977; *University City-Clayton Sun*, 1973 – 1977; and *St. Louis Lutheran*, 1945 – 1976, 1978 – 1980 and 1999 – 2003. The volumes are shelved with other oversized material in row 16A. The Department also holds the following newspapers on microfilm: *North St. Louis Community News*, 1931 – 1933 (includes 14th St. White Way News, Baden News, and West Florissant News); *Maplewood Champion*, 1912 – 1935; *Webster Groves News*, 1916 – 1950; and *Naborhood Link News* (Lemay), 1930 – 1969.

■ **National Genealogical Society Book Loan Collection**—While most research collections are reference-use only, the Special Collections Department is unique in that many items can be checked out or obtained through interlibrary loan. Thanks go to the National Genealogical Society (NGS), who chose to transfer its book collection to St. Louis County Library when it closed its own lending library in 2001. Although the collection does include many unique or rare items (family histories are one example) most items are not. What makes the NGS Collection special is accessibility. Items can be borrowed by anyone anywhere in the country for free through interlibrary loan.

Indexes

A source may be rich in genealogical information, but it is useless without a way to find specific data. The Special Collections Department has ongoing indexing projects to provide access to important sources. Indexes created so far include:

- **St. Louis, Missouri Naturalization**—An index to post-1906 naturalization records with more than 66,000 names.
- **Immanuel Lutheran Church records**—An index to baptisms, 1848 – 1909, and marriages, 1848 – 1920.
- **Newspaper indexes**—Including *Carondelet News*, *St. Louis County Watchman-Advocate*, *Revue de l'Ouest*, *Le Patriote*, and the *Westliche Post* (obituaries only).
- **Local history indexes**—The Department has an ongoing project to index church histories, histories of social organizations, local history books, and similar sources.

Special projects

Sometimes an opportunity comes along for a special project that is too important to pass up. One came to the Department's attention in 2000 during the inauguration of the Julius K. Hunter and Friends African American Research Collection (JKH). African American genealogical specialist Reginald Washington, who spoke at the event, told the Department staff about original recruitment records for the Civil War U.S. Colored troops held by the National Archives (NARA). The records had never been organized or described, and therefore were virtually inaccessible to researchers.

The Department contacted NARA about the records, resulting in a unique partnership with the JKH collection to organize, describe and film the 55 bound volumes pertaining to Missouri recruits. The project produced *Descriptive Recruitment Lists of Volunteers for the United States Colored Troops for the State of Missouri, 1863-1865* (NARA Microfilm Publication M1894) on six microfilm rolls. St. Louis University history major John R. Harris III, volunteers Rohini Sankaran and Anthony F. Kardis, and the Department staff created an [index for the records](http://www.slcl.org/branches/hq/sc/jkh/usctmo/) <<http://www.slcl.org/branches/hq/sc/jkh/usctmo/>>

usctmosoldiers.htm>. The Missouri State Archives has recently digitized the microfilm and made the records available online as part of the [Missouri Digital Heritage U.S. Provost Marshal Database](http://www.sos.mo.gov/archives/provost/) <<http://www.sos.mo.gov/archives/provost/>>

- **1940 U.S. Census news**—According to the National Archives (NARA) blog [NARAtions](http://blogs.archives.gov/online-public-access/?p=5500) <<http://blogs.archives.gov/online-public-access/?p=5500>>, the 1940 U.S. Census has been digitized and will be available on NARA's website beginning 2 April 2012. No name index has yet been created, but the schedules can be accessed by enumeration district. Enumeration district maps are online at [NARA's website](http://www.archives.gov/research/arc/) <<http://www.archives.gov/research/arc/>>.
- **Swedish American Genealogist now online**—*Swedish American Genealogist*, 1981–2007, is now available online for free through [CARLI](http://collections.carli.illinois.edu/index.php) <<http://collections.carli.illinois.edu/index.php>>, an online digital collection maintained by the Consortium of Academic and Research Libraries in Illinois (CARLI). *Swedish American Genealogist* is a quarterly publication of the Swenson Center at Augustana College in Rock Island, Ill.

Ohio, Oklahoma, Oregon, Washington, and Wisconsin. Township plat maps were prepared from the survey field notes taken by deputy surveyors and can include details such as roads or trails, lakes and rivers, forest or swampland, Indian lands, and improvements made on lands that had been settled before the survey took place. They also indicate township and section lines, section numbers, and acreage of holdings. Information can vary depending on when the survey was done and whether the lands were populated. Names of settlers, patentees, and claimants appear on lands where some settlement had taken place before the survey, and plats containing names of landowners in this collection have been indexed. Some maps also record land patent dates.

—Application information is arranged in packets than can be searched by name, place and date of birth and death, and application year. Genealogical information submitted may include references to Revolutionary War pension files, baptismal records, marriage records, cemetery records, census records, family Bible records, deeds, court records, documented family and local histories, and copies of applications to other lineage societies. Applications also typically include a short summary of the ancestor's service.
