The database is searchable, making it easy to find newspaper articles about specific persons or events. Although published more than 20 years ago, William Dollarhide's *Managing a Genealogical Project* (Baltimore: Genealogical Publishing, 1988; R 929.1 D665M and circulating copy) still serves as a concise, useful guide for keeping research organized. After a chapter on the types of genealogical projects and their impact on record keeping, the author gives advice on collecting notes and documents in a logical manner, extracting information and abstracting it onto forms, using genealogical numbering systems, presenting data in charts and narratives, and tips for keeping a research journal (a chapter on using a computer is dated and best ignored). An appendix provides forms that may be photocopied.

While including much of the information in Dollarhide's guide, *The Organized Family Historian* by Ann Carter Fleming (Nashville: Rutledge Hill Press, 2007; R 929.1 F5970; circulating copies are available at a number of St. Louis County Library locations) is a more in-depth and comprehensive handbook. In Part 1, the author discusses filing systems, organizing a work space, methods for keeping track of various information formats (books, CDs, maps, etc.), and dealing with photographs and heirlooms. Part 2 gets into the nitty-gritty of keeping organized while doing research. A chapter on note-taking

and record-keeping in general is followed by advice in dealing with various source types and venues. Part 3 discusses various issues related to publishing a family history. Fleming's experience and expertise make this publication an essential guide to family history research. Forms discussed by the author may be viewed and printed out from the book's companion CD-ROM. (The reference copy disc is held at the Special Collections Department reference desk. Ask for CD-ROM no. M48). The book is one in a series published by the National Genealogical Society's on standards and guidelines for genealogists.

When it comes to organizing data, a couple of other publications are worth mentioning. *Numbering Your Genealogy: Basic Systems, Complex Families and International Kin* by Joan Curran, Madilyn Coen Crane and John H. Wray (Arlington, Va.: National Genealogical Society, 2008; 929.1 C976N) is a comprehensive guide. Numbering systems are used in genealogical charts to differentiate individuals and make generational relationships more transparent. The booklet discusses standard numbering systems and suggestions for handling complex situations, such as adoption.

Finally, no genealogical research is complete (or even valid) without proper documentation and citation. Elizabeth Shown Mills's *Evidence Explained: Citing History Sources from Artifacts to Cyberspace* (Baltimore: Genealogical Publishing, 2007; R 907.2 M657E and circulating copies) is to genealogists what *The Chicago Manual of Style* is to writers and editors, and it has become the recognized standard. Mills discusses source analysis and demonstrates what information is necessary for proper documentation and citation. Examples of acceptable citation formats for every conceivable source and situation appear throughout. *Evidence! Citation and Analysis for the Family Historian* (Baltimore: Genealogical Publishing, 1997; R 929.1 M657E and circulating copies), also by Mills, is a concise guide useful for quick reference.

For those wanting more information about organizing a genealogical project, Ann Fleming will speak on the subject at the St. Louis Genealogical Society meeting on Saturday, Feb. 13, 10 am in the St. Louis County Library Headquarters auditorium. The meeting is free and open to the public.

To help you get started in organizing your family history, four-generation pedigree charts and family group sheets are provided on the next three pages. Print them out and use them as needed.

TIPS

- **Searching Special Collections web pages:** Special Collections Department web pages contain indexes with thousands of surname references. Searching for a surname on all pages at once is easy. At the [St. Louis County Library home page](http://www.slcl.org) <<http://www.slcl.org>>, enter the surname in the box under “Search this site” at the top right corner of the page. A list of web pages with the surname will result.
- **Emigration and immigration lists:** Books with emigration and immigration lists can be shelved in four different locations in the Special Collections Department: 1) with other books about the country, 2) with books with call numbers beginning 929.3, 4) with books with call numbers beginning 973.045, and 5) with books about specific states or counties. So, if you are browsing the shelves, be sure to check all of these possible locations.

WEB NEWS

Web finds

- **DAR Online Databases** <http://www.dar.org/library/online_research.cfm>: The Daughters of the American Revolution have recently posted on its website several databases with names of patriots and descendants. Searching on a patriot will result in a list of all DAR applications submitted by a descendant. Clicking on the application number results in more information. The database is also searchable by the name of a descendant. The site also provides access to the DAR’s library catalog.
- **Unreal City** <<http://digital.wustl.edu/w/whi/>>: This website contains digitized Whipple Fire Insurance Maps for the city of St. Louis. The images can be browsed, but maps are also searchable by street name or block number. Available maps cover 1870, 1874, 1876, 1889 & 1895. The site is very useful for research but can be quite slow.

New on Ancestry

- **Bavaria, Germany, WWI Personnel Rosters, 1914-1918:** Rosters include name of soldier, rank, birthdate, birthplace, religion, status or occupation, marital status, parents’ names, parent’s social station/occupation, parents’ residence, and service details.

■ **World War I Draft Registration Cards, 1917-1918:**

This updated database offers clearer images. Records for St. Louis County Draft Board #3, which were only added to the database after much delay, have apparently been removed. No explanation is given for this, but it may have been a result of the update.

Ancestry continues to make updates to existing databases and has been adding numerous titles to the German, French, and Canadian collections, so check back often.

Footnote Spotlight

- **Census records:** Footnote announced that they will be adding the entire United States Federal Census to its website. The 1900, 1910 and 1920 censuses are in progress; only about 1% of the records having been uploaded so far.

- **Native American records:** Footnote has a number of databases relating to Native American Research including Dawes Enrollment Cards, Dawes Packets, Eastern Cherokee Applications, the Guion Miller Roll and the Indian Census Rolls, 1885-1940.
